Approval of June 17, 2020 minutes; Mr. Drinkhall moved to approve the minutes and was seconded. Vote: All in favor, Mr. Dziedzic, Mr. Fougere, Ms. Frechette and Mr. Jensen abstaining.

The meeting continued with the School District Subcommittee's review of their recommended questions for the school department. The members of this committee included Mr. LeFebvre, Mr. Drinkhall and Ms. Leonard. This committee met four (4) times for a total of approximately six (6) hours. The Budget Committee asked for clarification on certain items including bonds, facilities planning, ionizer testing, revenue shortfalls, COVID-19 liability, student census, resource officers and the sending town agreements. Edits to the questions were proposed. After discussion, a motion was made by Mr. Jensen, seconded by Mr. Dziedzic, with all in favor, to forward the questions as amended to the school department. A copy of the amended questionnaire is attached to these minutes.

The next subcommittee to present was the Rules and Procedures Subcommittee which included Mr. Colbath, Mr. Laracy, Mr. Aughton and Ms. Ryan. This committee worked via email. Mr. LeFebve read a notice from Tom Holmes, Conway Town Manager, regarding filling vacancies for appointed Budget Committee members. Mr. LeFebvre reminded the Budget Committee that one fire district has had a vacancy on the Budget Committee for two (2) years. Mr. Colbath letv continued the meeting describing the support received from the municipal association attorney in addressing the proposed edits. Mr. Colbath reviewed Item #6 which confirmed the process for making changes to the Budget Committee Rules and Procedures. The Budget Committee asked questions and requested clarification on virtual meetings. A revised version of Rules and Procedures will be presented at the next Budget Committee meeting.

The final presentation was from the Town of Conway Subcommittee, consisting of Mr. Donohoe, Mr. Corbett and Mr. Jost. This subcommittee met in person and via zoom. Each of the committee met in person and via zoom. the nine (9) town questions were read aloud, followed by discussion. Edits were made to some the les
