PUBLIC HEARINGS

A public hearing was opened at 7:30 pm to consider a **VARIANCE** requested by **THE ESTATE OF EUGENE HUSSEY/JUSTIN HUSSEY** in regard to §147.13.14.3.1 of the Conway Zoning Ordinance to allow to construct a meter pit and meter station and allow underground pipes and conduits within the floodway off Valley View Road, North Conway (PID 231-139.03). Notice was published in the Conway Daily Sun and certified notices were mailed to abutters on Tuesday, November 20, 2007.

Shawn Bergeron of Bergeron Technical Services and John Pendleton of Dwyer, Donovan & Pendleton, Council for Pennichuck appeared before the Board. Ms. Sherman stated since she would have to step down there would not be a quorum to act on the applications, therefore, the applications would have to be continued.
